A Brief History – The past year challenged all of us in the work that we do. Even with these challenges, our coalition has taken great strides forward in our evolution as an organization, positioning ourselves to promote systemic changes to advance the economic mobility of all residents of our county.

2014 — A group of community members got together to discuss the MEOP report; with 22% of Forsyth County residents living in Asset Poverty, addressing this condition became a priority.

2019 — The Benefits Cliff community convening took place in November and served as the jumping off point for the Benefits Cliff learning groups, tasked with identifying testable solutions and pilot programs.

2021 — The ABC was officially granted its 501(c)3 status. Core initiatives around Advocacy, the Benefits Cliff, Coalition Building, Living Wage, and Financial Capabilities were relaunched. A prototype of the Asset Poverty Data Exchange was built with the help of the Data and Research Advisory Group.

2018 — The vision of financial stability for all residents of Forsyth County allowed the ABC to create a strategic plan and formed the leadership council. The group refocused their areas of impact and formed five working committees to move the strategic plan forward.

2020 — Despite the disruption of the COVID-19 pandemic, the ABC incorporated, filed for their 501(c)3 status, and hired their first Executive Director. This major milestone enabled the ABC to form a Board of Directors and to step into their role of coordinating and aligning our community's collective efforts around Asset Poverty and Financial Stability.

Asset Building Initiatives

We support strategic local initiatives designed to help individuals, families, and the community overall become more resilient to asset poverty.

We are working to identify innovative and equitable solutions to the Benefits Cliff locally by centering the voices of those with lived experiences.


Living Wage

The Benefits Cliff community learning groups were launched in November, 2019 at a community meeting that was collectively organized by the Asset Building Coalition, the Winston-Salem Foundation, Forsyth Futures, the Department of Social Services, and others. Attendees at that event were invited to participate in a learning group that would focus on one of three pathways to address the negative effects of the Benefits Cliff in Forsyth County – nonprofit solutions, employer solutions, and policy solutions. The learning groups would work together to create testable ideas that could be implemented using available funding.

Each group met in person five to six times between January, 2020 and the suspension of the work in March, 2020 due to the COVID-19 pandemic. The groups ranged in size from 7 to 14 people at each of those meetings. Each of the three groups had multiple members who were recruited based on their lived experience with the Benefits Cliff (nearly 50% of group members for two of the groups). Not only were the groups composed differently than most work groups, the groups were intentionally facilitated to center those with lived experience and foster a culture of learning and inclusion among individuals working together in new ways.

The groups made significant progress and generated multiple ideas and potential approaches. They also identified current gaps in our collective knowledge and potential next steps, which were often not the fully-developed programs that had originally been imagined. Those ideas were combined into a framework that was presented to a reunion/relaunch meeting of the learning groups that was held virtually in February, 2021.

The learning groups collectively generated lessons, ideas, and questions about moving forward. Many of the individuals from those learning groups still very much want to be involved in this work. The collaborative work around the Benefits Cliff in this community has reached the end of its first phase of work. Now, it is time to begin a new phase of work — one that somehow weaves together the Asset Building Coalition, the multiple organizations doing work in this area, and interested community members, especially those most impacted by the negative effects of the benefits cliff and other issues of economic mobility. The summary framework below was crafted from the work of the learning groups:

Policy

LINE OF SIGHT: comprehensive, accessible public benefits that support economic mobility for all

GOALS: develop a policy agenda, partner with other groups

Employers

LINE OF SIGHT: flexible, creative compensation and benefit options in fields likely to involve the cliff

GOALS: pilot ideas with a few employers, develop workable ideas

Nonprofits

LINE OF SIGHT: coordinated system of nonprofits that center those most impacted

GOALS: pilot a program to bridge cliff with money and support, engage potential program participants

Data & Stories

Deepen our understanding of the negative effects of the Benefits Cliff in Forsyht County.

Awareness & Action

Increase awarenss about the Benefits Cliff for policymakers, employers, nonprofits, and individual workers.

We were deliberate to center the leadership of those with lived experience of the issue of the public Benefits Cliff. We made the effort to make space for a different way of being together. It was challenging, rewarding work. This was different. I watched realizations dawn on people like, "Oh, they really do mean that I show up as an individual, not my title or organization" or "Oh, these folks may actually listen to and value my experience." We worked together to deepen our collective understanding of the benefits cliff. I am so

grateful for the courage of so many people to show up in different rooms, with different people, and have a different conversation. We so need more of those!

Financial Highlights

- In 2020, the Asset Building Coalition (ABC) received a \$648,000 grant from the Kate B. Reynolds Charitable Trust.
- Grant funding will be distributed over a three-year period.
- ABC received its first payment of \$214,666 in the 2020-2021 fiscal year.
- These funds are for collaborative work to increase the economic mobility of Forsyth County by tackling the Benefits Cliff crisis, reducing asset poverty, and encouraging businesses to pay living wages.
- ABC also received a \$45,000 grant for operational support from the Winston-Salem Foundation.
- A complete financial review of the 2020-2021 fiscal year will be available in the next few months. This review will detail all income and expenses for ABC.

Our Coalition is 34 members strong, and growing.
